The applicant shall complete and submit a Language Instructor Teaching Certificate Application to the Confederated Tribes of the Colville Reservation (CCT) Language Program:

- A. Verification process by the CCT Language Program.
 - a. The Language Program shall notify the applicant of the date, time, and place of the competency testing for the Language Instructor Certification.
 - b. The competency testing will be conducted by the CCT 'Language Certification Board'.
 - c. The applicant shall receive written notification of his/her test results within two (2) weeks of the testing date:
 - If the applicant passed, the CCT Language Program will send a verification notice of the Certificate to the applicant and to the Office of the Superintendent of Public Instruction, Olympia, WA.
 - ii. If the applicant did not pass, she/he will receive information on how and when to initiate a second attempt, if applicant desires to do so.
- B. Certification Process by the Washington State Office of the Superintendent of Public Instruction (OSPI)
 - a. Under RCW 28A-410.045 First peoples' language, culture, and oral tribal traditions teacher certification program Established Rules, (1)(2)(a) it states: "Only a participating sovereign tribal government may certify individuals who meet the tribe's criteria for certification as a teacher in the Washington state first peoples' language, culture, and oral tribal traditions teacher certification program."
 - b. The applicant shall contact OSPI for any questions or additional information on the requirements necessary in order to qualify for a Native American Language and Culture Certificate.

c. Upon the applicant's fulfilling all requirements for certification, the CCT Language Program will issue a Native American Language Teacher Certificate to the applicant and a copy will be sent to the Office of the Superintendent of Public Instruction.

VERIFICATION PROCEDURE

Information about the Competency Test

- At least (10) days before the test date, the applicant may request from the Colville Confederated Tribes Language Program a sample of a test question. No informative clues concerning content of responses will be given to applicants at this time.
- On the day of the test, a test administrator will give oral instructions on the logistics of test taking.
- The test questions shall be asked in the either the nsəlxcin, nxa?amxčín, or titoqatimt language.
- The applicant shall respond to each question in the either the nsəlxcin, nxa?amxčín, or titoqatimt (whichever he/she is seeking certification for) language to the best of his/her ability.
- Applicants shall be allowed (5) minutes to respond to each question.
- Applicants should provide comprehensive but concise responses to each question.

OVERALL STANDARDS AND CRITERIA CONCERNING COMPETENCY IN THE nsəlxcin, nxa?amxčín, or titoqatímt CULTURE AND LANGUAGE

An applicant who is seeking a Washington State Native American Language Certification for the teaching of the nsəlxcin, nxa?amxčín, or titoqatímt language shall successfully demonstrate his/her competencies according to the following criteria.

An Applicant shall:

- 1. Be able to communicate effectively, both orally and in writing in the nsəlxcin, nxa?amxčín, or titoqatimt language with fluency, eloquence and accuracy.
- 2. Be able to confidently guide students toward achieving conversational and cultural fluency, and ultimately, toward achieving advanced proficiency in either the nsəlxcin, nxa?amxčin, or titoqatimt language.
- 3. Demonstrate a general understanding of the nsəlxcin, nxaʔamxčín, or titoqatímt language and how traditional cultural teachings are acquired and used in the development of a person who desires to live holistically and to be guided by traditional teachings and values.
- 4. Be able to identify and understand the values and attributes of native language as a form of communication and culture as a connection to one's origin, self-identification, and history.
- 5. Know the nsəlxcin or nxa?amxčín or titoqatimt history and culture of the twelve tribes confederated on the Colville Reservation.
- 6. Demonstrate an understanding of nsəlxcin, nxa?amxčín, or titoqatimt Origin Stories, other stories and their relevance to the daily lives of nsəlxcin, nxa?amxčín, or titoqatimt people.

NATIVE LANGUAGE AND CULTURE CERITIFICATE ASSESSMENT INSTRUMENT AND SCORING SHEET

- A. The nsəlxcin, nxa?amxčín, or titoqatimt Language Assessment is conducted in the format of an oral and written interview. Applicants will be asked to provide in-depth information on six nsəlxcin, nxa?amxčín, or titoqatimt cultural categories deemed to reflect the major components of either the nsəlxcin, nxa?amxčín, or titoqatimt cultural knowledge. At the same time, the applicants are responding, they will be rated on their proficiency in either the nsəlxcin, nxa?amxčín, or titoqatimt language. Six (6) titles have been established for each cultural category, which will only be known to the rater. The questions could be related to one of the following topics.
 - 1. Twelve Tribes Confederated on the Colville Reservation
 - 2. Greetings
 - 3. Kinship terms
 - 4. Traditional Foods
 - 5. Animals
 - 6. Ethnobotany
 - 7. First Food Feasts
 - 8. Traditional music and dancing.
 - 9. Clothing (traditional and/or contemporary)
 - 10. Household articles
 - 11. Days/months/seasons
 - 12. Geography
- B. At least three (3) but no more than five (5) individuals who serve on the Colville Confederated Tribes Language Certification Board will rate the applicant.
 - 1. Directions will be recorded so that every applicant responds to the same voice each time.
 - 2. Responses will be recorded for any questions for follow-up or appeals issues.
 - 3. nsəlxcin, nxa?amxčín, or titoqatimt cultural knowledge will have 4 levels 4 being the highest.
 - 4. nsəlxcin, nxa?amxčín, or titoqatimt language proficiency will have 5 levels 5 being the highest.
 - 5. The final score will reflect an average of the ratings in the cultural knowledge and language proficiency.
- C. Upon completion of testing and scoring, a date will be set to reconvene applicant and board to receive a "Verification Notice" or "Denial Verification Notice" and feedback.
 - 1. If the applicant receives a "Verification Notice", the notice will be forward to the Washington State licensure Unit for background checks, etc. before a "Certificate" is issued.
 - 2. If the applicant receives a "Denial Verification Notice", the applicant may appeal to the CCT Language Program

Levels for nsəlxcin language teacher certification:

Beginning Level using memorization method and TPR

Be able to teach basic sounds used in the nsəlxcin language

Teach simple words and phrases

Teach some phonetics

Teach family lineage

Intermediate Level

Teach Introduction and greeting phrases

Be able to write and read phonetics

Be able to dissect verb conjugation and paradigms

Teach cultural activities

Advanced Level

Be able to carry on a conversation in the nselxcin language

Be able to translate and document language documents

Be able to teach cultural activities that come to a cumulative ending
